Circumstances Surrounding Death

On 4/13/2022, the Department received a report stating that a 15-year-old teenager and the mother were shot and killed by the father. The maternal grandmother found the bodies of the teenager and mother in the front yard. They were pronounced deceased at the scene.

The mother and father were divorced in 2018 and lived in separate homes.

In the hour leading up to the teenager's death, the mother and three children were getting ready to leave their home for school and daycare. The two youngest siblings were already in the car while both the mother and teenager were exiting the home and walking toward the car, with the mother holding the youngest children's backpacks. Before they were able to reach the car, the father arrived at the home and shot the teenager and mother.

The maternal grandmother was on the phone with the mother just minutes prior to the incident. The grandmother became worried when the mother told her that the father was at the home and she immediately started driving to the mother's home. The grandmother was worried due to the history of domestic violence in which the father battered the mother.

Law enforcement arrived on the scene and found the bodies of the teenager and mother on the ground, several yards away from the car.

One of the siblings told law enforcement, "Daddy did it."

The father fled the scene and was found several days later. The police located the father at a gas station. The father entered a bathroom at the gas station and shot and killed himself.

Dr. Alexis Jelinek of the Broward County Medical Examiner's office completed an autopsy on the teenager. The cause of death was determined to be "multiple gunshot wounds" and the manner was an "homicide."

The Broward County Sheriff's Office has jurisdiction over this case. No criminal charges were completed as the perpetrator committed suicide days after the incident.

Based on the information indicated above, the report was closed with "verified" findings of the death, internal injuries and threatened harm maltreatments. The teenager's father is the caregiver responsible.

Other Children in the Family

The teenager had two younger siblings. Both children were sheltered and placed in the custody of a relative.

Summary of Prior Agency Involvement with Family

There are five prior reports, between 2008-2018, all with concerns of family violence. The father has a documented history of violence toward the mother; he punched the mother in the face several times and he threatened to kill the mother when she asked for a divorce in 2018. In a 2016 prior report, in addition to the family violence concerns, there were concerns that the decedent had been "whooped" by the father causing her to have a swollen eye and multiple injuries in various stages of healing. In 2009, the family completed Court Ordered In-Home services to address the violence in the home. All of the reports were closed with verified and/or not substantiated findings and are related to violence in the home by the father.
