### Circumstances Surrounding Death

On June 14, 2022, the 15-year-old, mother, and maternal grandmother were shot to death by the stepfather in a murder/suicide.

During the investigation, the following information was gathered.

On June 14, 2022, the Casselberry Police Department was notified of a shooting that occurred in their jurisdiction at an apartment in Maitland. 911 was called by a victim of the incident. It is believed that the stepfather shot and killed the mother, the maternal grandmother, and the child. As responding officers entered the home two shots were heard. The stepfather was found in the residence with a gunshot wound to the head. The mother and maternal grandmother were found deceased by Law Enforcement upon entering the home. The stepfather was taken to a local hospital and declared deceased at 8:13 a.m. Emergency Medical Services transported the child to Altamonte Hospital.

On June 14, 2022, Victor Araujo-Lopez was pronounced deceased at 8:30 a.m.

The mother and father were having marital issues and the mother was making plans to meet with an attorney on June 16, 2022, to discuss filing for divorce. Per extended relatives, there was a history of unreported domestic violence between them. On June 9, 2022, contact was made with Law Enforcement due to concerns of the father having purchased a gun and the mother not feeling safe with it in the residence. It was determined that there were no threats or acts of violence at that time, so no Law Enforcement action was taken.

The Casselberry Police Department investigated the death of Victor Araujo-Lopez (2022-0001017). Their case is classified as a murder/suicide.

The Death Certificate was received on August 12, 2022, and indicated District 5 & 24 Medical Examiner Tera Jones, M.D., signed and certified the death certificate for Victor Araujo-Lopez on June 23, 2022. ME# 22-24-01457.

Cause of Death: Gunshot Wound of Chest

Manner of Death: Homicide

Cause of Death: Multiple Gunshot Wounds

Cause of Death: Multiple Gunshot Wounds

Cause of Death: Gunshot Wound of Head

Manner of Death: Suicide

On August 12, 2022, the Department of Children and Families' investigation was closed with:

- Verified Findings of Death, Physical Injury and Household Violence Threatens child as to Victor Araujo-Lopez, with Carlos Soto as the caregiver responsible.
