On March 23, 2022 the Department of Children's Services (DCS) received a referral with the allegation of severe Lack of Supervision Preliminary Near Death concerning Alleged Child Victim (ACV) [REDACTED] (DOB: [REDACTED]: 2-years) and severe Lack of Supervision concerning Alleged Child Victim (ACV) [REDACTED] (DOB: [REDACTED]: 4-years) with the Alleged Perpetrator listed as an Unknown Alleged Perpetrator. Allegations of Abuse Death and severe Lack of Supervision concerning [REDACTED] were added with the Alleged Perpetrators being his mother, [REDACTED] and her paramour, [REDACTED]. Allegations of non-severe Drug Exposed Child concerning ACVs [REDACTED] and [REDACTED] (DOB: [REDACTED]: 8-years) were added with the Alleged Perpetrators being their mother, [REDACTED]. The investigation was assigned to Child Protective Services (CPS) [REDACTED] by Team Leader (TL) [REDACTED]. The case was worked in conjunction with the Tennessee Bureau of Investigation (TBI), Detective (Det.) [REDACTED] and Det. [REDACTED] with the [REDACTED] County Sheriffs Department.

At the time of the alleged incident [REDACTED] and [REDACTED] lived part time with their mother, [REDACTED] her paramour, [REDACTED] maternal uncle, [REDACTED] and maternal grandfather, [REDACTED] in [REDACTED] County, TN, and part time with their father, [REDACTED] in North Carolina.

On March 23, 2022, [REDACTED] County Sheriffs Department was dispatched to a shooting at the maternal grandfather, [REDACTED] residence located at [REDACTED] in [REDACTED] TN. The mother, [REDACTED] her paramour, [REDACTED] maternal uncle, [REDACTED] and [REDACTED] were all at the home. [REDACTED] was reported to be at school and the grandfather, [REDACTED] wasnt home. Detective (Det.) [REDACTED] reported that they were initially told that the children, [REDACTED] and [REDACTED] were in the living room unsupervised when [REDACTED] was reported to have gotten a handgun in the home and accidentally shot his brother. Det. [REDACTED] reported that they later found out that [REDACTED] had accidentally shot himself after obtaining a gun from the mother and her paramours bedroom while they were in the shower together. The uncle, Mr. [REDACTED] was reported to be in his bedroom at the time of the incident. [REDACTED] was transported via ambulance to [REDACTED] Childrens Hospital to be treated for a gunshot wound to his head.

[REDACTED] [REDACTED] was pronounced deceased on March 28, 2022 at 10:54 pm [REDACTED]. He was an organ donor and kept on life support until March 29, 2022. He was taken straight to the Medical Examiners office once his organs were harvested.

March 23, 2022, Case Manager (CM) [REDACTED] spoke with Agent [REDACTED] with the Tennessee Bureau of Investigation (TBI) at the home of the alleged incident, [REDACTED] TN, concerning the Alleged Child Victim (ACV) [REDACTED] and his brother, [REDACTED]. There were 3 adults in the home at the time of the incident. Agent [REDACTED] reported the mother, [REDACTED], her paramour [REDACTED], and the maternal uncle [REDACTED] were the adults listed in the home. The home belonged to the maternal grandfather and grandmother, [REDACTED] and [REDACTED]. Ms. [REDACTED] and Mr. [REDACTED] took the child [REDACTED] to school and came back to the home. Ms. [REDACTED] reported when she came home, she changed [REDACTED] and [REDACTED] diapers and clothing. Ms. [REDACTED] and Mr. [REDACTED] then took a shower together. Ms. [REDACTED] asked her brother, Mr. [REDACTED] to watch the children while they showered. Agent [REDACTED] reported Ms. [REDACTED] reported Mr. [REDACTED] was in his bedroom playing video games and the two children were in the living room watching T.V. Ms. [REDACTED] reported while in the shower, Ms. [REDACTED] heard a boom. Ms. [REDACTED] ran out of the bathroom and found [REDACTED] lying on the floor in the living room in a puddle of blood. Mr. [REDACTED] called 911 and he said dispatch told him to remove the gun from the home and put it in the car, which is where we found it and magazine. Ms. [REDACTED] reported the gun was on the windowsill behind the bed, behind the curtain. Ms. [REDACTED] reported she took the magazine out of the gun before going to bed the night before, but there was still a bullet in the chamber. The bullet casing was stove piped, meaning the casing got lodged in the top of the gun due to not properly being ejected. It appears the brother, [REDACTED] may have shot [REDACTED]. The trajectory of the bullet is consistent with someone of the same size as [REDACTED] shooting him. The bullet went through the front of the face, near the eye, and exited out of the back of [REDACTED] head.

On March 23, 2022 Det. [REDACTED] engaged the mother, [REDACTED] at [REDACTED] Center. The mother informed Det. [REDACTED] that the father of the children, [REDACTED] wasn't allowed to have contact with the children and that he was on drugs. Ms. [REDACTED] also reported that Mr. [REDACTED] would have the handgun (9 mm) on this lap when they would exchange the children with the father which made her uncomfortable. Ms. [REDACTED] later recanted and stated that he has the children on the weekends and reported no court orders regarding contact or visitation. Ms. [REDACTED] was formally interviewed by the TBI and CPS was not provided the statement from that interview due to an on-going investigation.

On March 23, 2022 CM [REDACTED] engaged the father, [REDACTED] who reported that he is on the birth certificate of the children and he has the children on most weekends in N.C. Mr. [REDACTED] admitted to marijuana use and even smoking a joint on his drive to Tennessee once he learned of the incident on this date. Mr. [REDACTED] denied domestic violence allegations made against him by Ms. [REDACTED].

On March 23, 2022 Mr. [REDACTED] and Ms. [REDACTED] submitted to urine drug screens. Ms. [REDACTED] previously admitted to marijuana use and tested positive for THC, Meth, and Amp. Ms. [REDACTED] denied Meth use and stated that a couple of days ago she was with Mr. [REDACTED] at a friend's house where they were using Meth and she must have inhaled it but admitted to THC use the morning of March 23, 2022. Mr. [REDACTED] tested positive for THC and admitted to smoking a joint on the way to the hospital due to him being so upset about what happened to his son.

On March 23, 2022 CM [REDACTED] was unable to interview [REDACTED] as he left the residence before CM [REDACTED] arrived to an undisclosed location.

March 23, 2022 at approximately 2:30 PM, The Alleged Child Victim (ACV) [REDACTED] attended a forensic

interview on this date at the [REDACTED] Child Advocacy Center (CAC) in [REDACTED] TN. [REDACTED] [REDACTED] was the forensic interviewer. CM [REDACTED] [REDACTED] and Det. [REDACTED] [REDACTED] observed the interview in the observation room. [REDACTED] reported my brother shot himself with a gun. [REDACTED] reported he was watching T.V and saw him shoot himself in the eye. [REDACTED] reported [REDACTED] got a gun out of Uncle [REDACTED] room. [REDACTED] reported Uncle [REDACTED] was playing his game. [REDACTED] reported he heard Uncle [REDACTED] say dont get that gun. [REDACTED] reported he saw [REDACTED] walk in the living room with a gun. [REDACTED] reported his momma was screaming. [REDACTED] reported his mother said not to tell daddy about the blood on the living room floor. [REDACTED] reported Uncle [REDACTED] called an ambulance.

March 23, 2022 at approximately 3:30 PM, The Alleged Child Victim (ACV) [REDACTED] [REDACTED] attended a forensic interview on this date at the [REDACTED] Child Advocacy Center (CAC) in [REDACTED] TN. [REDACTED] [REDACTED] was the forensic interviewer. Case Manager (CM) [REDACTED] [REDACTED] and Detective [REDACTED] [REDACTED] with the [REDACTED] County Sheriffs Department observed the interview in the observation room. During the interview it was reported that [REDACTED] resides with her mother, [REDACTED] her mothers boyfriend, [REDACTED] [REDACTED] an uncle, [REDACTED] and grandfather on occasion. [REDACTED] stated that she wasnt home and was at school when her brother, [REDACTED] got a hold of a gun and was shot. It was further reported during the interview that her mom does have a gun and her mom and [REDACTED] both have the gun at the house and when they go out. [REDACTED] made no disclosures of abuse or neglect against her father, [REDACTED] [REDACTED] and she enjoys going to visit with him.

On March 24, 2022 an Immediate Protection Agreement (IPA) was agreed upon by the mother, Ms. [REDACTED] and the father, [REDACTED] [REDACTED] for the children to be placed in the care of Mr. [REDACTED] while agreeing to stay in Tennessee. The mothers paramour, [REDACTED] [REDACTED] will have no contact with all children.

On March 30, 2022 a preliminary hearing regarding the petition filed to remove [REDACTED] and [REDACTED] [REDACTED] into DCS custody before Judge [REDACTED] [REDACTED] in [REDACTED] County Juvenile Court. Judge [REDACTED] [REDACTED] ordered that the children should be placed with the father, [REDACTED] [REDACTED] who resides in N.C. Judge [REDACTED] [REDACTED] ordered that the mother, [REDACTED] [REDACTED] have supervised visits with no overnights with the children. CM [REDACTED] [REDACTED] developed a Family Permanency Plan to include that both parents would complete A&D Assessments, follow the recommendations of the assessments, the mother will complete a mental health assessment, follow the recommendations of the assessment, complete and attend parenting classes, and non-offender domestic violence counseling. The mother will be moving back to N.C. and provided CM [REDACTED] [REDACTED] with an address that is not with the children. CM [REDACTED] [REDACTED] engaged the parents about grief counseling for themselves and the children.

On August 18, 2022 The mother, [REDACTED] [REDACTED] and her ex-paramour, [REDACTED] [REDACTED] were arrested on this date regarding an indictment into the death of Ms. [REDACTED] son, [REDACTED] [REDACTED] Ms. [REDACTED] [REDACTED] was charged with 1 count of Aggravated Child Neglect and 1 count of Reckless Homicide. Mr. [REDACTED] [REDACTED] was charged with 1 count of Aggravated Child Neglect.

On March 31, 2022, an autopsy was performed on ACV [REDACTED] [REDACTED] by Assistant Medical Examiner [REDACTED] [REDACTED] DO, of the Regional Forensic Center, [REDACTED] TN. The autopsy reported that the cause of death is a gunshot wound to the head and the manner of death is best classified as accident.

On August 19, 2022, CPS Case Manager (CM) [REDACTED] [REDACTED] presented the case with allegations of Severe Lack of Supervision and Abuse Death against the mother, [REDACTED] [REDACTED] and her ex-paramour, [REDACTED] [REDACTED] regarding Alleged Child Victim, [REDACTED] [REDACTED] to [REDACTED] County Child Protective Investigative Team (CPIT). Those present were Assistant District Attorney (ADA) [REDACTED] [REDACTED], Youth Services Officer (YSO), [REDACTED] [REDACTED], Detective (Det.) [REDACTED] [REDACTED] with the [REDACTED] County Sheriff's Department, Det. [REDACTED] [REDACTED] and Chief [REDACTED] [REDACTED] with the [REDACTED] Police Department, CPS Team Leader (TL) [REDACTED] [REDACTED] and [REDACTED] [REDACTED] Children's Advocacy Center (CAC) [REDACTED] [REDACTED], and [REDACTED] [REDACTED].

The team agreed with the classification of Allegation Substantiated/Alleged Perpetrator Substantiated regarding both Lack of Supervision and Abuse Death against [REDACTED] [REDACTED] and [REDACTED] [REDACTED]. The severe Lack of Supervision allegation against an Unknown Alleged Perpetrator that was initially on the referral will be classified as Allegation Unsubstantiated/Alleged Perpetrator Unsubstantiated.

Per DCS Policy Work Aid 1 Section C:

Lack of Supervision:

Failure to provide adequate supervision, by a parent or other legal custodian/caretaker, who is able to do so. A lack of supervision allegation or determination means that:

- a) The child has been placed in a situation that requires actions beyond the child's level of maturity, physical ability, and/or mental ability; or
- b) Caregiver inadequately supervises a child. The caregiver is with the child, but is unable or unwilling to supervise (e.g., the caregiver is under the influence of alcohol or drugs, is depressed, sleeps during the day or has inadequate parenting knowledge or skills).
- c) Any registered sex offender residing in the home with unrelated minor children or victim of offender and/or caregiver knowingly resides with and/or allows children to be unsupervised with a registered sex offender.

Per DCS Policy Work Aid 1 Section B:

Drug Exposed Child:

This allegation pertains to a person under the age of eighteen (18) who: Has been exposed to or experiencing withdrawal from use, sale, or manufacture of a drug or chemical substance (including, but not limited to alcohol such as a diagnosis of Fetal Alcohol Syndrome, cannabis, hallucinogens, stimulants, sedatives, narcotics, methamphetamines, heroin, inhalants) that could adversely affect the child's physical, mental, or emotional functioning as a result of the actions or behaviors of the parent/caregiver; or Has a parent/caregiver that uses drugs or chemical substances that impacts their ability to adequately care for the child; or Has a parent/caregiver that has current addiction issues that could adversely affect the child's physical, mental, or emotional functioning.

Per DCS Policy Work Aid 1 Section G:

Child death is defined as:

- a) Any child death caused by abuse or neglect.
- b) Any unexplained death of a child when the cause of death is unknown or pending an autopsy report.
- c) Any child death caused by abuse or neglect resulting from the parent or legal custodian/caretaker failure to stop another person's direct action that resulted in the death of the child. Child deaths are always treated as severe abuse.

2. A near death, per Tennessee Code Annotated (TCA) 37-5-107(c)(4) is defined as a serious or critical medical condition resulting from abuse, neglect or child sexual abuse, as reported by a physician who has examined the child subsequent to the abuse or neglect. When an initial referral or a referral on an open case contains information that suggests the child is in a serious or critical medical condition as a result of the allegation(s) or has been determined to meet the criteria for an allegation of near death as defined above, the Child Abuse Hotline selects Preliminary Near Death (PND) Indicator in TFACTS on the participants tab on a new intake or the investigative persons tab on an active case. The information does not have to come from a physician. Preliminary near deaths are always treated as severe child abuse.

There is a preponderance of evidence to support the allegations of Abuse Death and severe Lack of Supervision against the mother, [REDACTED] [REDACTED] and against [REDACTED] [REDACTED] regarding ACV [REDACTED] [REDACTED] in that both were charged in connection with the death due to them being under the influence of methamphetamine and leaving a loaded gun within reach of the child which resulted in the child accidentally shooting himself causing his death. There is a preponderance of evidence to support the allegation of non-severe Drug Exposed Child

The Preliminary Near Death (PND) investigation regarding Alleged Child Victim (ACV) ██████████ ██████████ was debriefed with Case Manager (CM) ██████████ ██████████ and Team Leader (TL) ██████████ ██████████. Also present was Team Coordinator (TC) ██████████ ██████████, Statewide CPS Deputy Director (SCPSDD) ██████████ ██████████, Statewide CPS Director (SCPSD) ██████████ ██████████, and Director of Critical Incident Support (DCIS) ██████████ ██████████.

The CPS investigation was assigned on 3/23/22 concerning allegations of Lack of Supervision for ACV ██████████ ██████████ (2yo). It was reported ██████████ resided with his birth mother ██████████ ██████████ the mothers boyfriend ██████████ ██████████ and two siblings ██████████ ██████████ 4yo and ██████████ ██████████ 7yo] in ██████████ County.

On 3/23/22 at 8:41am dispatch was notified of an unresponsive male ██████████ ██████████ with a gunshot wound to the face and head. ██████████ was taken by ambulance to ██████████ Center and had emergency surgery to stop the bleeding. Bone was removed from the skull to relieve pressure, but the blood was not clotting, and ██████████ continued to bleed and the brain continued to swell. A CT scan was completed, and he was transferred to Childrens Hospital for specialized care. Prognosis is grim currently and ██████████ remains on life support.

TBI is involved in the investigation along with the Sherriffs Department. On the morning of 3/23/22 the mother reported she and her boyfriend left the home to take the 7yo sister to school. They came home and changed the boys clothes and the mother and boyfriend took a shower together. While in the shower, the mother reported hearing a loud bang. She left the shower and found ██████████ lying in a pool of blood. The uncle that was in the home ██████████ ██████████ called 911 and was advised to take the gun and put it in a vehicle outside to get it out of the house. The gun was a 9mm. The mother reported she removed the magazine from the gun the night before and the gun was sitting in the window sill, behind the bed and curtain in the bedroom. A gun residue test was performed on the 3yo as it was initially believed he had possible shot ██████████. According to the 4yo sibling during his FI, ██████████ got the gun and came into the living room with it and shot himself in the eye. The 4yo said he also heard ██████████ go into the uncles room and the uncle telling ██████████ to put the gun down. The 7yo reported seeing the gun in the past in a drawer and she has moved it to the side before. It was discovered the uncle also had a firearm in his room. The boyfriend allegedly told another party he left the gun

lying on the bed while they were in the shower.

The father has never been legitimated and was never married to the mother. The mother reported the father gave her the gun for protection and when they go to exchange the children, her boyfriend will have the gun in his lap. She additionally reported her boyfriend was a meth pusher. THC was found in the mothers car, and she admitted to smoking pot. The mother and father agreed to urine drug screens. The father was positive for THC and admitted to smoking pot on the way to the hospital due to anxiety. The mother admitted to smoking THC prior to the incident on 3/23/22. The mother was positive for THC, methamphetamine, and amphetamine. She denied meth use but believe it could be second hand from her boyfriend and his friend smoking at the friends house a couple days prior. An IPA was completed with the father for the siblings. The mother agreed to supervised contact and no overnights. The boyfriend has no contact.

GSR was completed on [REDACTED]. The uncle, [REDACTED] called 911 and was advised to put the gun in a vehicle outside which is where LE found the gun when they arrived in a vehicle outside. There were multiple guns inside the home but all were locked in a gun safe belonging to the maternal grandfather with the exception of the 9 mm that inflicted the injury to [REDACTED] and a 22 caliber pistol that was found lying on a table in a holster in the uncle's room. The Preliminary Near Death (PND) investigation regarding Alleged Child Victim (ACV) [REDACTED] [REDACTED] was debriefed with Case Manager (CM) [REDACTED] [REDACTED] and Team Leader (TL) [REDACTED] [REDACTED]. Bone was removed from the skull to relieve pressure, but the blood was not clotting, and [REDACTED] continued to bleed and the brain continued to swell. A CT scan was completed, and he was transferred to Childrens Hospital for specialized care. Prognosis is grim currently and [REDACTED] remains on life support.

TBI is involved in the investigation along with the Sherriffs Department. On the morning of 3/23/22 the mother reported she and her boyfriend left the home to take the 7yo sister to school. They came home and changed the boys clothes and the mother and boyfriend took a shower together. While in the shower, the mother reported hearing a loud bang. She left the shower and found [REDACTED] lying in a pool of blood. The uncle that was in the home [REDACTED] [REDACTED] called 911 and was advised to take the gun and put it in a vehicle outside to get it out of the house. The gun was a 9mm. The mother reported she removed the magazine from the gun the night before and the gun was sitting in the window sill, behind the bed and curtain in the bedroom. A gun residue test was performed on the 3yo as it was initially believed he had possible shot [REDACTED] [REDACTED]. [REDACTED] with the [REDACTED] County Sheriff's Department, Det. [REDACTED] and Chief [REDACTED] with the [REDACTED] Police Department, Team Leader (TL) [REDACTED] and [REDACTED] Children's Advocacy Center (CAC) [REDACTED], and [REDACTED]. CM [REDACTED] presented the facts of the case into the shooting death of ACV [REDACTED]. CM [REDACTED] also discussed the autopsy report and interviews completed throughout the investigation to include that the mother, [REDACTED] and her ex-paramour, [REDACTED] have been charged on an indictment from the TBI. Ms. [REDACTED] has been charged with 1 count of Aggravated Child Neglect and 1 count of Reckless Homicide and Mr. [REDACTED] has been charged with 1 count of Aggravated Child Neglect. The team agreed with the classification of Allegation Substantiated/Alleged Perpetrator Substantiated regarding both Lack of Supervision and Abuse Death. The severe Lack of Supervision allegation against an Unknown Alleged Perpetrator that was initially on the referral will be classified as Allegation Unsubstantiated/Alleged Perpetrator Unsubstantiated. The case is referred for prosecution and non-custodial services for the surviving siblings who are residing in N.C. with their father. Ms. [REDACTED] and Mr. [REDACTED] have restricted contact on those children.

Any documents received during the investigation has been uploaded into documents in TFACTS.

Summarize alleged perpetrator's statement or admission: What is the perpetrator's explanation of the incident(s)/allegation(s)?

On March 23, 2022 Det. [REDACTED] engaged the mother, [REDACTED] at [REDACTED] Center. The mother informed Det. [REDACTED] that the father of the children, [REDACTED] wasn't allowed to have contact with the children and that he was on drugs. Ms. [REDACTED] also reported that Mr. [REDACTED] would have the handgun (9 mm) on this lap when they would exchange the children with the father which made her uncomfortable. Ms. [REDACTED] later recanted and stated that he has the children on the weekends and reported no court orders regarding contact or visitation. Ms. [REDACTED] was formally interviewed by the TBI and CPS was not provided the statement from that interview due to an on-going investigation.

The mother denied Meth use and stated that a couple of days ago she was with Mr. [REDACTED] at a friend's house where they were using Meth and she must have inhaled it but admitted to THC use the morning of 3/23/22. The father tested positive for THC and admitted to smoking a joint on the way to the hospital due to him being so upset about what happened to his son.
