On 7/28/22 at around 4:45am, [REDACTED] arrived at [REDACTED] Children's Hospital by [REDACTED] Fire Department/EMS in a state of full arrest. He had been stabbed twice in the chest with a large kitchen knife, by his stepfather [REDACTED]. One of the stab wounds went through [REDACTED] chest and back. Life saving measures and CPR were given to [REDACTED] by the ER medical team at [REDACTED]. [REDACTED] was taken into surgery due to his injuries. He was pronounced deceased at [REDACTED] Children's Hospital around 5:30am. The attending physician was Dr. [REDACTED]. Cause of death was cardiac arrest due to the stab wounds. Abuse and neglect is suspected as the cause of death. No other injuries were observed on [REDACTED] body, other than the stab wounds. [REDACTED] body is currently at [REDACTED] Children's Hospital in the surgery room. The surgery room where he was pronounced deceased will be treated as a crime scene. [REDACTED] mother, is also deceased. It was reported that [REDACTED] was murdered by [REDACTED] as well. It was reported that her body was found in the front of the home. It is unknown what the circumstances were that led to the incident. The incident occurred in the front of the home in [REDACTED] County. [REDACTED] Police Department is currently involved. The details of the deaths are still being investigated. It is believed that [REDACTED] has been arrested. The whereabouts of [REDACTED] sibling is unknown. No one has been interviewed concerning the incident. There is no information on the living conditions of the home. There is no information on any drug alcohol use, previous domestic violence, or mental health concerns in the home. This investigation was submitted for review by Case Manager (CM) ██████████. The case was presented to the Child Protective Investigation Team (CPIT) and the allegations of Abuse Death and Domestic Violence naming ██████████ as the alleged child victim (ACV) and ██████████ as the alleged perpetrator (AP) has been classified as Allegation Substantiated Perpetrator Substantiated (ASPS). The allegation of Domestic Violence naming ██████████ and ██████████ as the ACVs and ██████████ as the AP has also been classified as ASPS. During a domestic violence incident, ██████████ was fatally wounded by Mr. ██████████ when ██████████ attempted to save his mother, ██████████ who was being attacked by Mr. ██████████. Ms. ██████████ was also killed during this incident. ██████████ and ██████████ were present in the home at the time of the incident. It is reported there had been a history of domestic violence. The CPIT members agree with the classification, and the CPIT forms have been uploaded in TFACTS. ██████████ and ██████████ entered DCS custody, but have exited via ICPC to the custody of their aunt who lives out of state. The closing summary has been reviewed and approved. The closing FAST has been completed with the following results: Immediate Intervention Not Recommended, Moderate Need/Risk. The 740 has been completed and will be forwarded to Juvenile Court Judge and District Attorney for classification. Team Leader ██████████ has reviewed the case file and is approving the investigation for closure.

On July 28, 2022, the Department of Childrens Services (DCS) received a referral for an allegation of Abuse Death regarding Alleged Child Victim (ACV) [REDACTED] (14-year-old). The alleged perpetrator (AP) is [REDACTED]. This investigation was assigned to Child Protective Services Case Manager (CM) [REDACTED]. The team leader (TL) is [REDACTED]. CM [REDACTED] (2nd) shift also participated in this investigation. [REDACTED] (14) lived at home with his birth mother, [REDACTED] who is also deceased. Also in the home were [REDACTED] (17) and [REDACTED] (13), the siblings of [REDACTED].

The Department of Childrens Services (DCS) received a referral on July 28, 2022, for the allegation of abuse death regarding alleged child victim (ACV) [REDACTED]. The alleged perpetrator (AP) is identified as [REDACTED]. On July 28, 2022, at around 4:45 a.m., [REDACTED] arrived at [REDACTED] Children's Hospital by [REDACTED] Fire Department/EMS in a state of full cardiac arrest. He had been stabbed twice in the chest with a large kitchen knife, by his stepfather [REDACTED] (who was later identified as [REDACTED]). One of the stab wounds went through [REDACTED] chest and back. Life saving measures and CPR were given to [REDACTED] by the ER medical team at [REDACTED] Childrens Hospital. [REDACTED] was taken into surgery due to his injuries. He was pronounced deceased at [REDACTED] Children's Hospital around 5:30 a.m. by the attending physician Dr. [REDACTED]. Cause of death was cardiac arrest due to the stab wounds and other injuries were observed on [REDACTED] body, other than the stab wounds. [REDACTED] (birth mother) was murdered as well, and her body was found in the front of the home.

On July 28, 2022, CM [REDACTED] made initial contact with [REDACTED] (ACV). She reports her mother allowed Mr. [REDACTED] to stay at the home for one night but explained to him she did not want to be in a relationship with him and that he could only stay for that night. Mr. [REDACTED] was angry when he came back for his belongings. He needed to obtain the rest of his belongings but refused to leave the home. Mr. [REDACTED] was able to get into the home due to her mother allowing him to borrow the key the day before to get in and out to retrieve his belongings. [REDACTED] reports Mr. [REDACTED] continued to attempt to enter the home. As quickly as they would lock the door, he would unlock it which eventually lead him into getting in. Mr. [REDACTED] rushed to the kitchen and obtained a knife and stabbed her brother, [REDACTED] (ACV), and her mother. [REDACTED] reports she was in the room hiding with her dog. She reports she called law enforcement, but she believes Mr. [REDACTED] got away.

CM [REDACTED] met with [REDACTED] on July 28, 2022. She reported that Mr. [REDACTED] and her mother broke up prior to him going to jail 3-months ago. [REDACTED] reported on Monday July 25th, 2022, her mother allowed Mr. [REDACTED] to spend the night at the house. He left Tuesday morning, but her mother gave him a key because they both had errands to run. She reports Mr. [REDACTED] returned to the home Wednesday July 27th, 2022, where he saw his belongings on the porch. [REDACTED] reports she was on the phone with her boyfriend but could hear the yelling become more intense as Mr. [REDACTED] tried to enter the home stating he needed to get something from the home. She reports once he entered the home he stabbed her brother, [REDACTED] who was trying to protect their mom, and Mr. [REDACTED] then stabbed her mother. She reports [REDACTED] ran from the home and collapsed on the street grasping for air. She ran behind him to get help from a neighbor reporting at some point her boyfriend called law enforcement. She reports Mr. [REDACTED] left the scene before law enforcement arrived.

On July 28, 2022, CM [REDACTED] met with [REDACTED] who reported that her sister, [REDACTED] broke up with Mr. [REDACTED] before he went to jail for pulling a gun on [REDACTED] and her nephew, [REDACTED]. Ms. [REDACTED] expressed that he went to jail for three months, but she does not know why. Ms. [REDACTED] reported the Mr. [REDACTED] got out of jail on July 24th and her sister allowed him to stay at the home on July 25th but she told him he had to leave. He came back to get his belongings, and [REDACTED] had put his bags outside. Ms. [REDACTED] reported that he had a key to the home. Ms. [REDACTED] was not at the home at the time of the incident and had no additional information to add.

On July 28, 2022, [REDACTED] completed a forensic interview at the Child Advocacy Center (CAC). [REDACTED] disclosed that sometime around 4 a.m. this morning her mothers ex-boyfriend [REDACTED] came to their house trying to get in. [REDACTED] told the interviewer that she along with her mother and 14 yr. old brother [REDACTED] were blocking the door to keep him out. She said that [REDACTED] was screaming and yelling for her mother to let him in, but she kept telling him that he needed to leave. [REDACTED] advised that her mother had already placed [REDACTED] belongings on the back porch after he had left the previous day. She stated that her mother had no intentions of him returning to their home. [REDACTED] disclosed that [REDACTED] left the door and began banging on the windows at which time her mother went to where he was trying to get in to ask him to leave. [REDACTED] said at some point she was the only one at the door trying to hold it, but [REDACTED] was eventually able to kick the door in and enter the home. She told the interviewer that when he entered the home her mother came towards him, requesting that he leave. [REDACTED] described standing in front of her mother and [REDACTED] standing beside their mother also telling [REDACTED] he needed to leave. [REDACTED] advised the interviewer that she stood in front of her mother because she was afraid that [REDACTED] was going to do something toward her mother. She said that she has never cared for him or got good feelings from him. She told the interviewer that [REDACTED] went looking for his things while telling her mother that she was a bad person and that she was doing all of this in front of the kids. According to [REDACTED] at some point [REDACTED] entered their kitchen grabbed a big kitchen knife and said that he was going to stab somebody. She said that the knife was gray with a black handle. [REDACTED] disclosed that she saw [REDACTED] stab [REDACTED] and at that point she ran into her mothers bedroom, locked the door and called 911. She said that she was not sure where [REDACTED] was stabbed but she believed it was his chest. She told the interviewer [REDACTED] fell but was eventually able to get out of the house along with their 16 yr. old sister [REDACTED] who went for help.

On July 28, 2022, an autopsy was completed by [REDACTED], M.D. at [REDACTED] Tennessee Regional Forensic Center. [REDACTED] sustained 2 stab wounds: one to the right arm and one to the torso. The cause of death is stab wound of the torso and the manner of death is homicide.

On January 4, 2024, CM [REDACTED] presented this case to the Child Protective Investigative Team (CPIT). Those in attendance were ADA [REDACTED], Sgt. [REDACTED] ([REDACTED] Police Department), TL [REDACTED], CAC Director [REDACTED], and CAC Staff [REDACTED]. The team agreed that there is a preponderance of evidence that supports the substantiation of the Abuse Death. The team also agreed that there is a preponderance of evidence that supports the substantiation of the domestic violence.

The medical records were obtained and have been uploaded in TFACTS.

- a) Any child death caused by abuse or neglect.
 - b) Any unexplained death of a child when the cause of death is unknown or pending an autopsy report.
 - c) Any child death caused by abuse or neglect resulting from the parent or legal custodian/caretaker failure to stop another persons direct action that resulted in the death of the child. Child deaths are always treated as severe abuse.
2. A near death, per Tennessee Code Annotated (TCA) 37-5-107(c)(4) is defined as a serious or critical medical condition resulting from abuse, neglect or child sexual abuse, as reported by a physician who has examined the child subsequent to the abuse or neglect. When an initial referral or a referral on an open case contains information that suggests the child is in a serious or critical medical condition as a result of the allegation(s) or has been determined to meet the criteria for an allegation of near death as defined above, the Child Abuse Hotline selects Preliminary Near Death (PND) Indicator in TFACTS on the participants tab on a new intake or the investigative persons tab on an active case. The information does not have to come from a physician.

Preliminary near deaths are always treated as severe child abuse.

Section F: Domestic Violence

Acts of violence, coercion, or intimidation against a parent or caregiver by an intimate partner that could cause injury to a child, and/or impact the caregiver(s) ability to provide for the basic needs of the child(ren) including food and supervision. Domestic violence includes, but is not limited to:

Physical violence such as hitting, shoving, spitting, destroying possessions, threats toward any member of the household, throwing things, and attacks.

Any form of domestic violence (to include but not limited to financial control, stalking, harassment, violence or threats of violence towards pets, or sexual assault) where the safety and/or wellbeing of the child is impacted.

There is a preponderance of evidence that supports the substantiation for all allegations against [REDACTED] [REDACTED]. This case will be closed and classified as Allegation Substantiated Perpetrator Substantiated for Abuse Death and Domestic Violence against [REDACTED] [REDACTED].

A petition was filed placing [REDACTED] [REDACTED] and [REDACTED] [REDACTED] in the custody of their aunt Ms. [REDACTED] [REDACTED] in Louisiana.

On March 27, 2024, TL [REDACTED] spoke with [REDACTED] [REDACTED] ([REDACTED] [REDACTED], ICPC Director) regarding the [REDACTED] [REDACTED] siblings who are currently living with their aunt in Louisiana. TL [REDACTED] was informed that the last court report was submitted July 2023 and an update would be requested by ICPC. It was recommended that the DCS Hotline in Louisiana be contacted to complete a courtesy visit to assess the safety and well-being of the children. TL [REDACTED] was informed that a concurrence has been requested for the ICPC to be closed.

CM [REDACTED] submitted a courtesy request to the DCS Hotline in Louisiana for a follow up visit with the siblings and received an email that stated "[REDACTED] [REDACTED] DCFS is unable to complete the courtesy request as per our conversation. Please contact ICPC in your local area. It is my understanding they are working with a relative in regard to the children listed in the request. They can provide any additional information that may be needed".

The Abuse Death investigation regarding Alleged Child Victim (ACV) [REDACTED] was debriefed with Case Manager (CM) [REDACTED] and Team Leader (TL) [REDACTED]. Also present was Team Coordinator (TC) [REDACTED] Statewide CPS Director (SCPSD) [REDACTED] and Director of Critical Incident Support (DCIS) [REDACTED].

The CPS investigation was assigned on 7/28/22 concerning the death of ACV [REDACTED] (14yo). It was reported [REDACTED] resided with mother [REDACTED] and two siblings [REDACTED] 12yo and [REDACTED] 16yo in [REDACTED] County.

[REDACTED] and his mother were fatally stabbed by the mothers boyfriend [REDACTED] at the familys home on 7/28/22. Mr. [REDACTED] came to the home to pick up his belongings and the mother had placed them outside the home. Mr. [REDACTED] then proceeded to attempt to gain access to the home through the door and succeeded by using a key. The mother and boyfriend then became involved in altercation during which [REDACTED] became involved as well. Mr. [REDACTED] grabbed a knife and stabbed [REDACTED] in the chest and the mother as well. [REDACTED] then went outside and 911 was called. [REDACTED] was transported via ambulance to the hospital where he died. The mother died at the scene.

2nd Shift CM made response at the family home. Both siblings were present in the home at the time of the incident. The 12to sibling witnessed the incident and was forensically interviewed. She reported the mothers boyfriend came to the home and was upset with mother and forced his way in. Once inside he was yelling at the mother and brother and grabbed a knife and stabbed [REDACTED] and slit her mothers throat. The 16yo sibling was on the phone with her boyfriend at the time of the incident and only witnessed the situation after the stabbings had occurred and was with [REDACTED] while waiting on the ambulance to arrive. The 16yo was interviewed at the home. Counseling services are being set up for the siblings through the CAC as well additional grief counseling support. The children reported their fathers are not involved and not in the Unites Stated which left them without a guardian. A NCPP was completed with a maternal cousin to the children and agreed to keep the children in her home until temporary custody was awarded by the court, which occurred on 8/3/22. Additionally, a plan is in process for the children to stay with a maternal aunt in Louisiana through child services there. Backgrounds were completed on the cousin and her paramour with no concerns. CM has also discussed applying for benefits for the children with the cousin, who is in he process of doing so. A referral has been made to the relative caregiver program as
