CCDFS received a report that the child's adult caregiver contacted 9-1-1 due to the child being found in the family's pool. The child was pulled from the pool and life saving measures were commenced. Emergency medical personnel responded to the residence and transported the child to a local hospital emergency room. Upon medical assessment, the child was determined to be in critical condition. There is a concern regarding supervision of the child at the time the incident occurred. Local law enforcement is investigating the event.

On 6/4/2023, CCDFS received notification that the child was pronounced deceased.
