Circumstances Surrounding Death

On April 9, 2023, the 7-year-old and 13-year-old children passed away after being shot by the father of the 7-year-old.

According to the mother and law enforcement, the following information was provided.

On April 9, 2023, the senior child protective investigator spoke with the detective who reported that there were four people deceased as a result of the incident - the maternal grandmother, the two children, and the father of the 7-year-old.

The detective confirmed the mother and her paramour (father to the 7-year-old) had telephone conversations on Sunday April 9, 2023, at 1:04 a.m., 1:13 a.m., 1:21 a.m., 2:01a.m. 2:16 a.m. and 2:20 a.m. At 2:21 a.m. the mother called 911 and reported a verbal domestic incident with possible shots fired. At 2:28 a.m. law enforcement arrived on scene and the perpetrator was observed to be naked in front of the home with a gun, and he was subsequently killed by law enforcement. Inside of the home the three victims were found suffering from gunshot wounds. The grandmother and 13-year-old were pronounced deceased on scene and the 7-year-old was rushed to Orlando Medical Center where he was later pronounced deceased.

On April 9, 2023, Damionna Reed was pronounced deceased at 2:44 a.m.

On April 9, 2023, Cameron Bouie was pronounced deceased at 3:59 a.m.

On April 10, 2023, the senior child protective investigator met with the mother at her hotel room. The mother was emotional as she described the days leading up to the incident. The mother indicated the father of the 7-year-old had been acting weird and out of his norm. The mother denied knowledge of any mental health issues with him. The mother indicated that on April 8, 2023, at approximately 11:30 to 11:40 p.m. she went to a night club with a friend. On April 9, 2023, at 12:53 a.m. the 13-year-old texted her stating the 7-year-old's father entered her room and stated, "Busted you tried to set me up with the Mexicans". The mother then contacted the father via Facetime at 1:04 a.m., where he was observed seated on the bed, wearing a white tank top, and watching television. The mother asked him what he said to the 13-year-old, and he remained silent. The mother informed him that he needs to chill out and that she's on her way home. The father then replied, saying, "No enjoy yourself". The mother stated she immediately left the club, telling the friend she's ready to go, informing the friend that the father was "tripping".

At 2:16 a.m. the mother spoke to the father, told him he needed to chill and that she was on her way home from the club. At 2:18 a.m. the mother received a text from the maternal grandmother stating, "Help..he is shotting a gun...call police". The mother tried calling her daughter and the maternal grandmother with no response. Upon her arrival home at some point after 2:28 a.m. (when law enforcement arrived) the entire street was blocked off and the 7-year-old's father was dead in the street. The mother attempted to go to the house but was stopped by law enforcement.

(Based on the documented times from law enforcement the mother's statement about leaving immediately does not appear to be accurate as the Facetime call was at 1:04 a.m., the drive time between the club and the mother's home is approximately 16 minutes, and the mother did not arrive home until after 2:28 a.m.)

The mother declined to drug screen.

Contact was made with the biological mother of the 7-year-old. She advised that the father had a power of attorney for the child and the child had lived with him and the mother of the 13-year-old for the past two months. She did not think he would do something to harm their son and she denied any knowledge of him having any mental health issues.

The Orlando Police Department investigated the deaths of Cameron Bouie and Damionna Reed 2023-00130691). Their case was closed as a multiple homicide with the death of the perpetrator occurring in a shoot out with law enforcement.

The death certificate was received on April 25, 2023, and indicated District 9 Medical Examiner Sara H. Zydowicz, M.D., signed and certified the death certificate for Cameron Bouie on April 18, 2023. ME# 23-09-00744.

Cause of Death: Gunshot Wound of Torso

Manner of Death: Homicide

The death certificate was received on May 8, 2023, and indicated District 9 Medical Examiner Sara H. Zydowicz, M.D., signed and certified the death certificate for Damionna Reed on April 25, 2023. ME# 23-09-00750.

Cause of Death: Multiple Gunshot Wounds

Manner of Death: Homicide

On June 6, 2023, the Department of Children and Families' investigation was closed with:

- Verified Findings of Death and Physical Injury as to Cameron Bouie and Damionna Reed, with Lacorvis Daley as the caregiver responsible.
