 CCDFS received information regarding a murder-suicide. An adult male family member shot four other family members an adult female and three juveniles before shooting himself. Both adults and two juveniles were deceased on scene, and a third juvenile was transported to a local hospital and listed in critical condition. Law enforcement is investigating the event.

CCDFS has the following prior CPS history for this child or member of the child's family or household:

7/11/2022 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, allegations of neglect were found unsubstantiated and an allegation of abuse was found substantiated. Based on assessment, the family was referred to a community resource for services. The family was also provided with a community resource guide for future reference, if needed. At the conclusion of the case, the minors were determined to be safe, and the case closed 11/22/2022.
