### **Circumstances Surrounding Death**

On May 8, 2023, a report was received indicating the mother's paramour shot and killed the 11-year-old and 17-year-old children as well as the 21-year-old adult sibling and the mother on the morning of May 2, 2023. It is suspected he believed the mother was having an affair. The paramour fled the scene and was found by law enforcement in Seminole County at his brother's home in Sanford. A stand-off occurred, and the paramour died in a shoot-out with law enforcement.

According to law enforcement, the following information was provided.

On May 2, 2023, sometime around 5:00 a.m., the mother's paramour became upset with the mother and was armed with a firearm. The paramour used the firearm on the mother and her three children. All four of them passed away from gunshot wounds. The mother and three children were not found until approximately 16 hours later by Law Enforcement. An arrest warrant was issued for the paramour on four counts of First-Degree Murder. On the morning of May 3, 2023, the paramour was located by Law Enforcement in Sanford, FL at a motel, where his brother resided. There was a standoff with Law Enforcement and the paramour was killed.

On May 2, 2023, Kianis Castillo-Pizzaro, Ariana Segarra-Pizzaro, Darian Hernandez-Pizzaro, and Marlene Pizzaro were pronounced deceased at 8:54 p.m.

The Lake Wales Police Department investigated the deaths of Kianis Castillo-Pizzaro and Ariana Segarra-Pizzaro (23-1077). Their case was closed out as a quadruple

murder with the perpetrator dying in a confrontation with law enforcement in Seminole County.

The death certificate was received on May 23, 2023, and indicated District 10 Medical Examiner Stephen J. Nelson, M.D., signed and certified the death certificate for Kianis Castillo-Pizzaro on May 17, 2023. ME# 23-10-FA-312.

Manner of Death: Homicide

The death certificate was received on May 23, 2023, and indicated District 10 Medical Examiner Stephen J. Nelson, M.D., signed and certified the death certificate for Ariana Segarra-Pizzaro on May 18, 2023. ME# 23-10-FA-311.

Cause of Death: Gunshot Wound of Head

Manner of Death: Homicide

On June 30, 2023, the Department of Children and Families' investigation was closed with:

- Verified Findings of Death, Physical Injury, Internal Injuries, and Household Violence Threatens Child as to Kianis Castillo-Pizzaro and Ariana Segarra-Pizzaro, with Al Stenson as the caregiver responsible.
