## 1. Circumstances Surrounding Death

On November 21, 2023, this 10-month-old infant died as a result of injuries received during a house fire.

On November 21, 2023, the sibling's father entered the home and stabbed the mother while she was sleeping. He then lit all of the burners on the stove, placed paper on top of them, and started a house fire while all of the children were sleeping. He then fled the scene. Law Enforcement, EMS, and the Fire Department arrived and extinguished the fire. They discovered the children had received burns and transported them to Halifax Hospital. They also discovered the mother had been stabbed and she was pronounced dead on scene. Despite life saving efforts, the infant was pronounced deceased at 1:22am.

The mother and the siblings' father had a on again/off again tumultuous relationship. They had an active parenting plan that included an ongoing child support case. The siblings' father was not happy about the child support case, and it is believed he and the mother recently were fighting about it.

The Medical Examiner completed an autopsy on the infant and determined the cause of death as thermal and inhalational injuries. The manner of death was a homicide.

The Medical Examiner completed an autopsy on the mother and determined the cause of death as stabbed by another individual. The manner of death was a homicide.

The Volusia County Sheriff's office opened an investigation and arrested the siblings' father. He was charged with two counts of murder, two felonies for committing an act that could cause death, and first-degree arson of a dwelling while people were present.

Based on the information obtained during the investigation, DCF Volusia County Child Protective Investigations closed the investigation on June 22, 2025, with verified findings of death due to burns with the siblings' father as the caregiver responsible. There were also verified findings of burns against the children by their father.

The family has been involved in seven prior investigations between 2018 and 2023.
