On October 24, 2022, the agency received a report regarding a 1-month-old infant pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant; the autopsy report is pending. No criminal charges have been filed in this case and the investigation remains open.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by his mother and father. The agency deemed the infant's sibling unsafe and initiated a Protective Plan. Subsequently, the Protective Plan was terminated, and the infant's sibling was taken into Temporary Physical Custody and placed with a relative. A Petition for Protection or Services was filed, and the case remained open to provide ongoing case management services.
