Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On October 25, 2023, the agency received a report regarding a 10-month-old infant who was found deceased in her home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office noted no signs of trauma to the infant and determined the cause of death was acute drug intoxication. As a result of law enforcement's investigation, the infant's mother was criminally charged with Neglecting a Child (Consequence is Great Bodily Harm). A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office noted no signs of trauma to the infant and determined the cause of death was acute drug intoxication. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of neglect to the infant by the mother and the father. The agency determined the infant's twin 10-month-old sibling, 2-year-old sibling, and 8-year-old half-sibling unsafe and initiated a Protective Plan. Subsequently, the siblings were taken into Temporary Physical Custody and placed with a relative. Petitions for Protection or Services were filed, and the case remained open to provide ongoing case management services.

On November 28, 2016, the agency screened-in a CPS report alleging neglect to the infant's now 10-year-old half-sibling by the father and the 10-year-old half-sibling's mother. An assessment was completed by the agency, and the allegation of neglect was unsubstantiated. The case was closed upon completion of the Initial Assessment.
