Description of the incident, including the suspected cause of death, injury or egregious abuse or neglect:

On October 26, 2023, the agency received a report regarding a child pronounced deceased in his home. Law enforcement was contacted and initiated a criminal investigation. The Medical Examiner's Office found that the death was non-accidental; the autopsy is pending. As a result of law enforcement's investigation, a non-relative household member was charged with 1st Degree Intentional Homicide, Physical Abuse of a Child (Repeated Acts Causing Death), and Hiding a Corpse, and another non-relative household member was charged with 1st Degree Intentional Homicide, Physical Abuse of a Child (Repeated Acts Causing Death), Hiding a Corpse, and First Degree Recklessly Endangering Safety, Use of a Dangerous Weapon. A criminal charge is merely an allegation, and a defendant is presumed innocent until and unless proven guilty.

Findings by agency, including maltreatment determination and material circumstances leading to incident:

The agency collaborated with law enforcement and medical professionals to complete the assessment. The Medical Examiner's Office found that the death was non-accidental; the autopsy is pending. The Initial Assessment completed by the agency found a preponderance of the evidence to substantiate maltreatment of physical abuse to the child by the non-relative adult household members. The Initial Assessment completed by the agency also found sufficient evidence to substantiate maltreatment of neglect to the child by the mother and father. The child's siblings remained in the home under a Safety Plan. The case remained open to provide voluntary case management services.
